## UTILITY FACILITIES AGREEMENT FOR VANDEBROOK, INC. (FIRST ADDITION TO VANDEBROOK)

THIS AGREEMENT is made this 22<sup>nd</sup> day of FEBRUARY ESCENTION by and between Vandebrook, Inc., hereinafter referred to as "Vandebrook" and the City of Waterloo, a municipal corporation, organized and existing pursuant to the laws of the State of Illinois, in the County of Monroe and in the State of Illinois, hereinafter referred to as "City";

WHEREAS, Vandebrook is the developer of a subdivision in Monroe County, Illinois, known as First Addition to Vandebrook, a plat of which is recorded in the Office of the Recorder of Deeds of Monroe County, Illinois, in Plat Envelope 194C, hereinafter referred to as "First Addition;" and

WHEREAS, Vandebrook has installed a sewer line and related sewer facilities, hereinafter referred to as "Sewer Facilities," in and under First Addition; and

WHEREAS, Vandebrook has installed a water line and related water facilities, hereinafter referred to as "Water Facilities," in and under First Addition; and

WHEREAS, Vandebrook has agreed with the City to transfer the ownership of the Sewer Facilities and Water Facilities upon acceptance thereof by the City; and

WHEREAS, the City has agreed to accept said Sewer Facilities and Water Facilities.

NOW, THEREFORE, for and in consideration of the premises and the agreements contained herein, it is mutually agreed as follows:

- 1. Vandebrook does hereby assign, transfer, convey and quit claim to the City the Sewer Facilities and Water Facilities and does hereby agree that any extensions or additions to said Sewer Facilities and Water Facilities shall become the property of the City upon the installation thereof, without further action upon the part of Vandebrook, when such extensions or additions are accepted by the City.
- 2. No extensions or additions to the Sewer Facilities and Water Facilities shall be made by Vandebrook or any other person or entity without written permission of the City.
- 3. The City does hereby accept the Sewer Facilities and Water Facilities and assumes responsibility for the maintenance and operation of same.
